TERMS AND CONDITIONS OF SALE

Each Buyer and Seller authorizes Auction to act as his agent and trustee to purchase, sell and transport vehicles, transfer ownership thereof and execute any disclosure statements relating therefore. Except for Auctions own negligence, each Buyer and Seller agrees to indemnify it, hold it harmless and defend it against all claims, loss, damage, expenses and attorney fee that it may sustain by reason of acting as his agent and trustee.

All guarantees are of the Seller only. The Auction makes no guarantee or representation of any type. All cars sold for \$2000.00 or less, sold "AS IS"—no guarantee or warranties, expressed or implied. Stolen vehicles are to be settled from the purchase price, less 2% per month and are sole responsibility of the Seller. Buyer agrees to honor payment of any check or draft immediately when presented to his bank for payment. And under no circumstances will he stop payment for any reason whatsoever unless approved by the Auction. Then if approved, Buyer is to return vehicle at his expense. Auction does not provide insurance coverage on vehicle consigned to it for sale, purchase, storage and related transportation and except for its own legal negligence, the legal or equitable owner of the vehicle agrees to assume all risks of loss, damage and disability arising from such ownership and shall provide insurance for same. Whether or not Auction inspects vehicle consigned to it for sale it is only to determine if certain items are on the vehicle (power brakes, power steering, a/c, radio, etc.) and no inspection is ever made by Auction as to the working condition of the item or vehicle and, Seller is responsible for representations of description, condition, mileage and disclosure statements relating to said vehicles. Seller's representation, which can be verified by inspection, shall be in effect only for such time on the day of sale. Boats, motorcycles, trailers, RV's- all sold "AS IS" - no guarantee or warranty, expressed or implied. Unless otherwise declared, Seller warrants and represents to Buyer and Auction:

- That vehicle is in a safe condition to operate in the public highways and complies with applicable laws relating to safety, performance and environmental standards.
- That to the best of my knowledge and information, the description, conditions known defects, mileage and disclosure statements accurate and fully disclosed.
- The vehicle has not been used as a taxi or law enforcement.
- That the vehicle has never been in a flood, and is not homemade, modified, rebuilt or reconstructed. That any change of engine, transmission, or any major assembly has not taken place.
- That Seller has good title to vehicle, free and clear of all liens or encumbrances, which he will defend against all claims and demands.
- That vehicle does not have a salvage, reconditioned, or insurance dated title. That vehicle does not have a reassigned serial number on title.
- That vehicle does not have a cracked block, frame damage, diesel conversions, and is not a kit car.

Unless so stated in the announced conditions to the consigned vehicle, Seller will be held liable for all expenses incurred due to any misrepresentation. Auction does not guarantee

the year of any vehicle or unit consigned. Seller and Buyer agree that the Auction is neither responsible for odometer mileage nor the information contained in the odometer mileage statement which Seller is required to complete and Buyer acknowledges. Seller and Buyer also agree to indemnify and hold Auction harmless from any liability, loss, cost, damage or expense. Including attorney's fees, which may arise either directly from any discrepancy between actual mileage of the vehicle and the guarantee mileage as disclosed in the odometer disclosure statement. Auction does not guarantee the status of Seller's title. Seller and Buyer understand that the Auction is merely assisting in the transfer of ownership documents and makes no representations or warranties regarding title. An outside Arbitrator will conduct arbitration of all matters concerning this Auction and its decision will be final. All arbitration's can only consist of engine, transmission, and rear end only. Arbitration of the vehicle will only take place if the cost of repair exceeds \$400 except for Frame Damage which is allowed 7 days. This will also include ABS systems if found to be in excess of \$500 or more. There is a \$70.00 fee and must be paid and reported to a clerk in the office within an hour after the sale has finished. Any vehicles with frame damage must be reported within 7 days and the mileage has to be reasonable. By signing below Seller and Buyer agree to abide by these terms. Failure to comply with our rules prohibits you from doing business here at Sparkling City Auto Auction.
